Sebastopol City Council Meeting December 4, 2018 – Synopsis and Commentary

- All council members were present.

Proclamations/Presentations:

- Years of service awards went to the following:
 - Erik Billing for five years with the public works department
 - Cameron Fenske for five years with the police department
 - Marc Simpson for 25 years with the fire department
 - Mike Simpson for 25 years with the fire department
 - Timothy McHale for 25 years with the fire department
 - Steve Thibodeau for 35 years with the fire department.

Consent Calendar:

- A resolution declared that Sarah Glade Gurney, Una Glass and Patrick Slayter have been elected to the office of the City of Sebastopol City Council for a four-year term ending in 2022. It also confirmed that the existing, extended 0.5% sales tax will stay in force until the cows come home or until it's repealed by the lowly voters if it defies all odds and somehow manages to get on a ballot. The cows will win this race as they will with the 2% bump in the transient occupancy tax, aka the hotel tax.

Presentation:

- Mayor Slayter was appointed vice mayor.

Public Comment (aka Open Mike):

Regular Agenda Item:

- At the request of Council Members Gurney and the absent Carnacchi, this item had been placed on the agenda for discussion about the cell tower at [501Petaluma Avenue](#). The residents and EMF irregulars were out in force, grumbling about many things, including Mayor Hinton's merciful two minute limit for each public comment speaker. The comments were generally the same. While some of the professed maladies appeared to be serious, no scientific causal relationship between the cell tower and the maladies at 501 Petaluma Avenue was demonstrated. The council agreed to write a letter to [Crown Castle](#) asking them to shut the tower off, move it or just get rid of it.
